Application are invited from eligible candidates for admission to,

1. First (I) Year of **Three Years Diploma Course in Handloom & Textile Technology (DHTT)** and
2. Second (II) Year of **Three Years Diploma Course in Handloom & Textile Technology (DHTT)** directly under **LATERAL ENTRY SCHEME**.

#### 1. Eligibility Criteria and Educational qualifications:

Name of Course	Duration	Eligibility
Diploma Course in Handloom & Textile Technology (DHTT)	Three (3) Years	Passed 10 <sup>th</sup> Std./SSc examination. Obtained at least 35% marks in the qualifying examination with English as a subject of study.
Diploma Course in Handloom & Textile Technology (DHTT) (Direct Second Year admission under Lateral Entry scheme)	Two (2) Years	Should have passed 10+2 examination with Mathematics, Physics, Chemistry OR Should have passed 10+2 examination in vocational stream of any textile discipline.* OR 10 <sup>th</sup> Pass + 2 Years of ITI, shall be eligible for admission to Second Year Diploma Course*

#### Note:

- 1.\* The candidates will undergo bridge courses for Mathematics, Physics and Chemistry, offered by IIHT Jodhpur, as per the guidelines.
2. In case of the Board having system of grading in 10<sup>th</sup> /12<sup>th</sup> Examination, the candidate must endorse the proof of details of marks with their application form to enable the selection committee to prepare merit list which is prepared on the basis of marks secured.

## 2. Age Limit:

“The age limit for admission to the first year of the Diploma Course in Handloom & Textile Technology for all the categories except SC/ST should be between 15-23 years and for SC/ST candidates it should be between 15-25 years as on 1st – July 2025. In case of admission into the direct second year under Lateral Entry, the maximum age limit will be 27 for SC/ST candidates and 25 for other than SC/ST candidates”.

## 3. Reservation :

- i. The respective State Governments will follow their reservation policies for SC/ST/OBC etc.
- ii. In addition to above, minimum 20% of the total seats allotted to the states are reserved for candidates belonging to Weavers Community. Shortfall if any will be met out from the candidates other than weaver's community.
- iii. One seat is reserved for the economically weaker section (EWS) candidate.

## 4. Numbers of Seats to be admitted:

Admission to I Year of DHTT	<b>09 Seats (Including one seat for EWS candidate)</b>
Admission to II Year directly under LE system*	<b>06 seats</b>
*Note:- As per the guidelines, maximum of 10% of approved intake plus the unfilled vacancies from the previous year / first year can be filled under LE system and it is subject to approval of the competent authority.	

## 5. Application for Admission:

The state government will invite applications for admission to first year/ second year of Diploma in Handloom & Textile Technology either through press or other Media publicity in the prescribed application form (Annexure-II/III) tentatively on or before the date as per the calendar.

- i. A copy of the advertisement shall be sent to this office immediately after it's publication.
- ii. The filled-in applications will be received by state office as per the calendar.

## **6. Preparation of Merit list:**

All the eligible Candidates who have submitted Application Form on or before the last date specified in the Application Form/ Advertisement shall be allotted a merit number.

- i.** Merit List of all the eligible candidates will be prepared by the Selection Committee comprising Director of Handlooms Textiles/Director of Industries & Director, IIHT, Jodhpur or his representative to verify the qualifying standard and other eligibility conditions depending upon the State reservation policy. A common merit list of all eligible candidates (prepared based on reservation/category wise) will be submitted to IIHT Jodhpur, for issue of offer of counselling to the eligible candidates.
- ii.** Aggregate of marks obtained in class 10th or equivalent qualifying examination in case of Admission to First Year/12<sup>th</sup> or Equivalent qualifying examinations in case of Admission to Second Year under Lateral entry, shall be basis for the purpose of determining the merit.
- iii.** State Government shall decide and mention the actual no. of seats to be reserved for various categories as per their prevailing reservation policy and for weavers' community out of total seats allotted to the state.
- iv.** In the event of two candidates securing identical marks in aggregate then the candidate who had secured more marks in the Science subject will stand higher in the merit.
- v.** If under extra ordinary circumstances the above conditions also remain identical, the eligible candidate having less age will be on higher merit. However, even if this also remains identical, the alphabetical order of the name of the candidates will be criteria for merit i.e. English alphabet A to Z.

In case of LATERAL ENTRY ADMISSION, the following order of preference and the methodology shall be followed to decide the merit, in case to two candidates securing identical marks.

- i.** Higher percentage of marks in the subject of Mathematics at HSC;
- ii.** Higher percentage of marks in the subject Science (aggregate of physics & chemistry) at HSC;
- iii.** Higher percentage of marks in the subject English at HSc;
- iv.** Merit shall be determined by the date of birth, the older candidate being the senior

## 7. Counselling

- i. After receiving the merit list from the State Government, The Director, Indian Institute of Handloom Technology Jodhpur will invite the candidates for Counselling at the Institute itself under intimation to concerned state government *in the ratio of 1:3 of the seats allotted to respective state.*
- ii. Counselling Committee will comprise of Director / Assistant Director or DDO / Senior Lecturer (TP) / Senior Lecturer (Textile) of Indian Institute of Handloom Technology, Jodhpur and Director of Handlooms & Textiles of the concerned State or his representative.
- iii. The candidates shall be required to produce all certificates in **original** such as educational, caste, Weavers community, EWS certificate, Domicile, Character, Birth Certificate and medical certificate with one set of attested photocopy of all and four (5) copies of his/ her photograph identical to the one pasted on the application form at the time of counselling/ grant of admission.
- iv. **A candidate who is allotted a seat will be required to pay Institute/Course admission fee only in demand draft /digitally on the spot at the time of admission. The fee structure will be intimated to the candidate in the counselling letter. Part payment will not be accepted. If a candidate fails to pay the fee, immediately after the seat is offered to him/her, the offer will be withdrawn and the seat will be allotted to the next candidate in the merit list. In case a candidate drops out after taking admission, his/her full fee will be refunded as per the rule.**
- v. A candidate, who fails to appear in person on the notified date and time for counselling, shall forfeit his/her claim for the seat offered to him/her and such seat will be offered to the next candidate in the merit.
- vi. Vacancies arising due to cancellation/any other reasons for admission in DHTT course will be calculated and notified. Remaining candidates of concerned state in the merit list, who could not get chance in 1st Counselling due to their lower position in the merit list, will be invited in 2nd counselling along with candidates in the combined merit list of all the wait listed candidates of all the states under the jurisdiction of this Institute. (if required)
- vii. In case the seats are not filled even after the list of the eligible candidates of the state and the combined merit list of all the wait listed candidates of all the states is exhausted then inter Institute-wise merit list of eligible candidates will be prepared and 3rd Counselling would be conducted as per the above procedure.
- viii. No TA/DA will be given to candidates for attending the counselling.

## 8. Stipend

Each student admitted into the course, both to I year and II year under lateral entry, will be eligible for a Monthly Stipend of Rs.2500/- to be paid 50% by central and 50% by state Government as per the guidelines, for the duration of course (tenable for 10 months per annum).

- i. The payment of stipend is linked to the attendance and academic performance. Accordingly, the student must have 80% of class attendance to become eligible for the monthly stipend.
  - ii. The student must not have any back paper and in special cases, one back paper is allowed.
  - iii. The student selected for admission will be required to submit a declaration on a non-judicial stamp- paper (Rs. 100/-) duly attested by Notary in the prescribed form.
9. Counselling and admission will be conducted on the dates to be notified later as per the extant guidelines issued by the Development Commissioner for Handlooms, New Delhi.

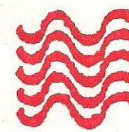
