Workstreams of EoDB Branch

Industries Department

- 1. LEADS (Logistics Ease Across Different States): LEADS is an indigenous data-backed index assessing the logistics infrastructure and services across 36 States/UTs. LEADS exercise act as a guiding & bridging mechanism for the identification of interventions enhancing logistics efficiency across India. In the LEADS 2023 Report, states have been classified under four categories viz. coastal states, landlocked states, north-eastern states, and Union Territories. Delhi emerged as the top performer among UT's and was ranked under the "Achievers" category in the LEADS 2023 Report.
- 2. PM Gati Shakti National Master Plan: PM Gati Shakti National Master Plan provides comprehensive database of the infrastructure planning for ongoing & future projects of various Ministries. GIS platform is being developed by BISAG-N for integrating all infrastructures on a single platform to aid in planning large infrastructure projects. Industries Department is the nodal Department for implementing the PM Gati Shakti NMP in the NCT of Delhi. Institutional bodies such as Empowered Group of Secretaries (EGOs), Network Planning Group (NPG) and Technical Support Unit (TSU) have been formulated and notified. 27 out of 28 essential layers pertaining to Delhi have already been updated on the portal.
- 3. **Business Reform Action Plan (BRAP):** The BRAP exercise aim to provide a conducive business environment by simplifying regulations and ranking the states in terms of various Ease of Doing Business measures, Sustainable business reforms have resulted in Delhi witnessing improvement of its ranking under the BRAP exercise. According to the latest assessment, Delhi has been categorized under the "Emerging Business Ecosystems" category. The BRAP 2022 comprised of 352 reform points and had both business-centric as wells as citizen-centric reforms. The BRAP 2024 comprises of 489 reform points with 287 reform points in BRAP and 110 reform points in BRAP+, out of which 196 reform points have been successfully submitted on the BRAP portal.
- 4. Minimizing Regulatory Compliance: Reducing Compliance Burden (RCB) exercise is a systematic exercise carried across all Central Ministries/Departments and States/UTs to eliminate/reduce compliances having adverse impact on time and cost of businesses. It is a historic initiative envisaged to improve the country's business climate by either eliminating the redundant laws or reducing the clearance procedures. Since 2020, Delhi has reduced more than 550 burdensome compliances. In 2024, 23 New Acts under RCB+ have been introduced, focusing on categorizing compliance processes into Identification, Simplification, Elimination, Digitization, and Decriminalization. Out of the total number of 92 reforms 56 have been successfully submitted on the portal.

- 5. **Single Window System:** The Govt. of NCT of Delhi is in the process of developing its own Single Window System for business clearances. The Single Window System is a medium for:
 - a) Information dissemination for investors
 - b) Issue of various clearances, licenses & certificates required for setting up and operations of an enterprise.

Hon'ble ACS(Industries) launched the Beta Version of Single Window System on 30th September 2024. The portal has successfully onboarded 59 services of 13 stakeholder departments in addition to CIN & PAN verification functionalities on the portal for user authentication. The portal also has a dedicated Policy feedback module for inviting feedback on draft public policies from the general public. The second phase of the development of the system is nearing completion with 5 additional departments expected to complete their API integration with the SWS of GNCTD by May 15th, 2025. Integration with the National Single Window System (NSWS) is expected to be completed by May 15th, 2025.

- 6. **Start-up Ecosystem:** The Govt. of NCT of Delhi has been working relentlessly over the past years towards fostering innovation and entrepreneurship in Delhi. The State emerged as the *Emerging Startup Ecosystem* in building a robust startup ecosystem in the country for nurturing innovation and providing opportunities to budding entrepreneurs in the latest States Startup Ranking Results 2022, launched in January 2023. The Council of Ministers has approved the Delhi Startup Policy, which is presently in due process of notification.
- 7. **PMFME:** Ministry of Food Processing Industry (MoFPI) has launched the Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME) scheme under the Aatmanirbhar Bharat Abhiyan with the aim of enhancing the competitiveness of existing individual micro-enterprises in the unorganized segment of the food processing. DSIIDC is the implementing agency providing 35% capital subsidy (up to Rs. 10 lakh) for existing units and ODOP based new units. Training, Incubation, Marketing, etc. are also envisaged under PMFME.
- 8. CLP: The city logistics policy envisages to assess baseline situation of City Logistics and identify issues and challenges for selected commodity sectors and identify strategies for a sustainable operation through stakeholder participation. The policy also aims to develop a cost-effective, inclusive, and environment friendly freight transportation system for Delhi that contributes to the city's economic growth, facilitates ease of logistics, decongests the city.
