b) To hear review petition/appeals against cancellation of allotment/ determination of lease by Head of Department, Industries Department, GNCT of Delhi.	b) Financial Commissioner, GNCT of Delhi.

The above mentioned officers shall exercise the powers to the extent that has been delegated to them.
