Application are invited from existing and functioning Primary handloom weavers specifive societies and apex handloom cooperative federations of Delhi for availing financial sistance as Marketing Incentive (MI) Component under the National Handloom Development ogramme (NHDP) for the year 2021-22 who fulfill the following criteria:

- To fulfill the eligibility criteria pertaining to household industry as per MPD-2021 to become eligible for financial assistance under the scheme.
- (ii) Registration with Registrar Cooperative Societies of Delhi.
- (iii) Audited statement of accounts of concerned handloom federation and primary handloom weaver cooperative society (PHWCS) duly authenticated by RCS Department, for the last three years, 2018-19.2019-20and 2020-21.
- (iv) Proof of last election and last AGM held of the federation and primary handloom weaver cooperative society (PHWCS) as per RCS Act and Rules.
- Resolution to the effect handloom federation primary handloom weaver cooperative society (PHWCS) want to avail assistance for Marketing Incentive Component of Comprehensive Handloom Development Scheme.
 - Any I.D. proof or Weavers I-Card issued by DC (Handlooms) of weaver members of federation and primary handloom weaver cooperative society (PHWCS) availing assistance under the Scheme.
- (vii) Proof of repayment of government dues, if any, deposited under the scheme 'Loan cum Grant for Modernization of Looms' up to 20th December, 2021 for those members of the society who are members of Federation.
- (viii) Proof of payment of government dues of rent, if any, deposited for sheds allotted to handloom cooperative federations for their member societies at Bharat Nagar and Nand Nagri Weavers Complex up to 20th December, 2021.
- (ix) The handloom cooperative society and handloom cooperative apex federation should be in existence and functioning.



All above documents should be attested by President / Secretary / Treasurer of the society who has been duly authorized by Management Committee for signing and self-attesting all documents.

- For the purpose of MI claim, Handloom Mark is made compulsory i.e. the societies selling their products should necessarily use handloom mark. The MI would be given on the sale of handloom products, using handloom mark only.
- (xii) The societies will purchase the yarn from NHDC. For buying yarn from open market, the societies will need NOC from NHDC.
- (xiii) In prescribed pro forma B-1 along with name and details of handloom cooperative society giving its details of bank account with IFS Code.
- (xiv) The assistance will be restricted to a maximum of 5 working looms per year (house of industry).
- As per GoI guidelinesn, An upper cap of Rs. 30 lakh of annual turnover is fixed for eligibility for release of Marketing Incentive so that needy societies are covered within the available budget. Societies having more than an annual turnover of Rs. 30 lakh are not eligible for MI.




