Sub: Inviting applications for Loan-cum-Grant for Modernisation / Renovation / Purchase of Handlooms in the Cooperative Sector in the year 2021-22

Sir,

- 1. Applications are invited from the registered Primary Weavers' Handloom Cooperative Societies of Delhi for financial assistance as Loan-cum-Grant for purchase / modernization / renovation of Handlooms and pre-loom equipments.
- 2. Assistance under the scheme is available as 2/3<sup>rd</sup> loan and 1/3<sup>rd</sup> grant. The maximum limit of loan cum grant is Rs. 50,000/- Loan component is recoverable in ten equal annual instalments with interest. In case of default in repayment, penal interest will be charged. The rate of interest and penal interest may change from time to time depending upon the instructions from the Govt. of India / Govt. of National Capital Territory of Delhi. Defaulter Handloom Cooperative Societies are not eligible for assistance under the Scheme.
- 3. All such handloom cooperative agencies interested in availing above said scheme from Govt. of Delhi should fulfill the following criteria before applying and should submit the following documents:
  - (i) To fulfill the eligibility criteria pertaining to household industries as per MPD-2021 to become eligible for financial assistance under the scheme.
  - (ii) Registration with Registrar Cooperative Societies of Delhi.
  - (iii) Audited statement of accounts authenticated by RCS Department, for last three years, 2018-19, 2019-20 and 2020-21.
  - (iv) Proof of last election and last AGM held of the society as per RCS Act and Rules.
  - (v) Resolution the effect agency wants to avail assistance under the Scheme of Loan cum Grant.




- (vi) Any I.D proof or Weavers I-Card issued by D.C (Handloom) of weaver members of PHWCS availing assistance under the Scheme.
- (vii) Proof of repayment of government dues, if any, deposited under the Scheme' Loan cum Grant for Modernization of Loom's up to 30<sup>th</sup> Octoberber,2021.
- (viii) Proof of payment of government dues of rent, if any deposited for sheds allotted to handloom cooperative agencies at Bharat Nagar and Nand Nagri Weavers Complex up to 30 Octoberer,2021
- (ix) The president /Secretary should certify separately that the handloom cooperative society is in existence and functioning.
- (x) All above documents should be attested by president/Secretary/Treasuer of the society who has been authorized by Management Committee for signing and self-attesting all documents
