Entrepreneurs of Delhi are hereby informed that the Ministry of Small Scale Industries, Govt. of India has enacted a comprehensive legislation known as "Micro, Small and Medium Enterprises Development Act., 2006". Implementation of the enactment has come in to force w.e.f. 02-10-06. The broad points and salient features of this enactment are as under.

- Manufacturing Enterprised: Enterprises engaged in the production of goods pertaining to any industries in the first schedule to the industries (Development and Regulation Act, 1951) are as under;
  - Micro Enterprises Where the investment in plant and machinery (excluding the cost of land & building) is up to Rs. 25 lakh.
  - (ii) Small Enterprises Where the investment in plant and machinery (excluding the cost of land & building) is above from Rs. 25 lakh & up to Rs. 5 Crore.
  - (iii) Medium Enterprises Investment in plant and machinery is more than Rs. 5.00 crore but not exceeding Rs. 10.00 crore.
- 2. Service Enterprises: Enterprises engaged in providing or rendering services are classified as under:
  - (i) Micro Enterprises Where the investment in equipments is up to Rs. 10 lacs.
  - (ii) Small Enterprises Where the investment in equipments is above Rs. 10 lakh & up to Rs. 2, crore.
  - (iii) Medium Enterprises Where the investment in equipment is above Rs. 2.00 crore and up to Rs. 5.00 crore.
- 1. SSI Registration
  - (a) The existing SSI registration has now been dispensed with immediate effect and is made simpler by filing Enterpreneur's Memorandum.
  - (b) Filing of memorandum is optional for all Micro and small enterprises
  - (c) Filing of memorandum is optional for service sector medium enterprises
  - (d) Filing of memorandum is mandatory for manufacturing sector medium enterprises.
  - (e) Dy. Commissioner of Industries (Registration) in the Office of the Commissioner of Industries, Govt. of NCT of Delhi has been designated as nodal authority to accept the memorandum.
  - (f) The form of Memorandum is in two parts. Any person who intends to establish a Nicro or Small Enterprise engaged in providing or rendering of services and engaged in production of manufacturing of products shall file Part I of the Entrepreneurs Memorandum with the aforesaid authority.
  - (9) Once the enterprises start production or start providing or rendering services, they shall file Part II of the Enterpreneurs Memorandum.
  - (h) In case of non filing of Part II of the Enterpreneurs Memorandum within two years of the filing of Part I, the Memorandum (Part I) filed by the entrepreneur will become invalid.
  - (i) In case of change in the investment in plant and machinery or change in the product and that of services or addition in product or service, enterprises which have already filed Entrepreneurs Memorandum should inform (the nodal authority of the same, in writing, within 3 months of the aloresaid changes.
- 4. Zoning Regulations:
  - (a) In addition to the above, Industrial enterprises are required to be established in accordance with the provisions of the Master Plan for Delhi-2001 and in permissible use zones. Therefore, Entrepreneurs Memorandum will not be accepted if proposed activity is to be carried out in the non permissible area/premises.
  - (b) Entrepreneurs Memorandum Part I will not be accepted if it is not supported with the Jollowing documents:
  - (i) "Consent to establish for setting up the enterprise from DPCC.

    (ii) Entrepreneurs memorandum Part II to be supported with "valid consent
  - (ii) Entrepreneurs memorandum Parl II to be supported with "valid consent to operate" from Delhi Pollution Control Committee and valid klunicipal Corporation Licence from Municipal Corporation of Delhi.
